JUDGING, EXHIBITION & AWARDS

Judging will be done remotely on calibrated monitors. Entrants will be advised of their acceptances by 25 March 2011. All images put forward to the final round will be printed for exhibition and for possible publication in the catalogue. In order for this to be done the entrants will be asked to large files. These files will be destroyed immediately after the printing of the images.

At the conclusion of the salon all digital entries will be destroyed and the prints will be donated to the Missionvale Care Centre in Port Elizabeth.

The winners of the awards will only be announced at the Awards ceremony to be held in Port Elizabeth on Wednesday 27 April.

CATALOGUE

All images receiving awards will be included in a printed catalogue which may be ordered online after the salon. A Digital catalogue will be produced and must be ordered at the time of entering.

CONDITIONS OF ENTRY - 1st PSSA International Digital Salon

- 1. The exhibition is open to anyone, anywhere. An entry may be rejected when the sponsoring organization or its agent, in some reasonable discretion, believes the entry does not conform to the exhibition rules and conditions.
- 2. Each author may submit a maximum of **4 Digital Images** per section.
- 3. Entries may only be submitted via our website www.salonmanager.co.za
- 4. All entries must be resized to a maximum of 1024px on the horizontal axis and a maximum of 768px on the vertical axis. Files must be saved in the Jpeg format and once compressed should be no larger than 500kb
- 5. The entry fee is:

Overseas Entrants: US\$9-00, per section entered or US\$21-00 if all three sections are entered South African Entrants: PSSA Members R20, 00, per section entered or R50, 00 if all three sections are entered.

South African Entrants: Non PSSA Members R25, 00 per section entered or R65, 00 if all three sections are entered.

Payment may be made using Paypal or electronic banking.

- 6. A DVD with all accepted images will be available at an additional cost of \$25-00 USD for overseas entrants, and R40-00 for South African entrants.
- 7. A photo book catalogue will be available and may be ordered directly on line.
- 8. Entries must originate as photographs (image-captures of objects through light sensitivity) made by the entrant on photographic emulsion or acquired digitally. By virtue of submitting an entry, the entrant certifies the work as his/her own and permits the sponsors to reproduce the images on a low resolution salon CD, on the website, salon exhibition and/or a photo book catalogue. The entered material may be used free of charge for publication or display in media related to the exhibition. The exhibition assumes no liability of any misuse of copyright.
- 9. A digital image is defined as a raster, 2 dimensional, rectangular array of static data elements called pixels, intended for display on a computer monitor or projected with a data projector. All the images in the will be judged using a calibrated monitor using Club Viewer software.
- 10. An entrant's four images will be distributed throughout four rounds of judging
- 11. Name your file using only the title of the image- the first letter of the title should be capitalized, with the rest being lower case (unless requiring capitalization for a specific reason). Each image must have a unique title. No other information is necessary as this will be automatically entered once you have completed the portfolio information on the web site.
- 12. No judge or family member may enter sections in which he or she is judging.
- 13. Details for submission of larger files for the exhibition and printed catalogue will be advised to the successful photographers.

DEFINITIONS

"NATURE photography is restricted to the use of the photographic process to depict observations from all branches of natural history, except anthropology and archeology, in such a fashion that a well informed person will be able to identify the subject material and to certify as to its honest presentation. The **story telling** value of a photograph **must** be weighed more than the pictorial quality while maintaining high technical quality. Human elements shall not be present, except on the rare occasion where those human elements enhance the nature story. The presence of scientific bands, scientific tags or radio collars on wild animals is permissible. Photographs of artificially produced hybrid plants or animals, mounted specimens, or obviously set arrangements, are ineligible, as is any form of manipulation that alters the truth of the photographic statement. No techniques that add to, relocate, replace, or remove pictorial elements except by cropping are permitted. Techniques that enhance the presentation of the photograph without changing the nature story or the pictorial content are permitted. All adjustments must appear natural.

In order to verify the authenticity of an image the Salon Director may request Medal and COM winners to supply the original RAW images, original slides and/or original jpeg images either side of the image.

All processing procedures performed on a digital image must be done by the photographer.

OPEN - Subject matter is open.

Images may be altered, either digitally or otherwise, by the maker and artwork or computer graphics created by the entrant may be incorporated if the photographic content predominates.

The image may not include any elements produced by anyone else but the photographer. All processing procedures performed on a digital image must be done by the photographer.

PEOPLE OF THE WORLD - People in any form must be of major importance in the image.

Images may be altered, either digitally or otherwise, by the maker and artwork or computer graphics created by the entrant may be incorporated if the photographic content predominates.

The image may not include any elements produced by anyone else but the photographer. All processing procedures performed on a digital image must be done by the photographer.
